Starting a new treatment brings up a lot of questions. One question may be how you will pay for your medicine. **GSK** understands how stressful this can be, so we have created the Together with GSK Oncology Co-pay Program for commercially insured patients to help with out-of-pocket costs.



HOW DOES THE CO-PAY PROGRAM WORK?

- Helps with the patient's cost share for ZEJULA medicine up to a total of \$26,000 for up to 12 months
- The patient cost share for office visits, labs, and other ancillary services is **not** included in the Co-pay Program

AM I ELIGIBLE?



You may be eligible if you:

- Have a commercial prescription insurance plan
- Are a resident of the United States (including the District of Columbia, Puerto Rico, and the US Virgin Islands)



You are not eligible if you:

- Are covered by any federal or state prescription insurance program, including Medicare Part B, Medicare Part D, Medicaid, Medigap, Veterans Affairs (VA), Department of Defense (DoD) programs, or TriCare. This may also include state pharmaceutical assistance programs and other federal or state plans not listed.
- Are Medicare eligible and enrolled in an employer-sponsored group waiver health plan or government-subsidized prescription drug benefit program for retirees.
- Are enrolled in a state or federally funded prescription insurance program. You may not use this program even if you elect to be processed as a cash paying patient.
- Are on Medicare Part D, even if in the coverage gap.

HOW DO I APPLY?

There are three ways to apply for the Together with GSK Oncology Co-pay Program for Zejula:



OPTION 1

Apply online.

Patients can apply for the Together with GSK Oncology Co-pay Program online by visiting TogetherwithGSKOncology.com, selecting ZEJULA, and clicking “apply” under Co-pay Assistance.



OPTION 2

Work with your healthcare provider.

Patients can download the ZEJULA Together with GSK Oncology enrollment form, select Co-pay Assistance, and work with their healthcare provider to complete and fax the form to 1-800-645-9043.



OPTION 3

Have a healthcare provider or specialty pharmacy submit for you.

Healthcare providers and specialty pharmacies can submit an application on behalf of their patients by visiting TogetherwithGSKOncology.com, selecting ZEJULA, and clicking “apply” under Co-pay Assistance. **Please note: the patient’s email is required.**

Once the healthcare provider or specialty pharmacy submits the patient’s information, the patient will receive an email requesting the patient’s signature.

If you qualify for the Co-pay Program and are enrolled, you will receive a virtual card that can be used by in-network specialty pharmacies or your healthcare provider’s office. The card expires one year after enrollment. If you continue to be eligible, you can work with your healthcare provider’s office to reapply for the program.
